- A. I am a Registrant of the BC College of Oral Health Professionals (the "BCCOHP") with a registration status limited to the speciality of pediatric dentistry;

THEREFORE, I, Dr. Sukrit Grewal, do hereby provide the following formal Undertakings to BCCOHP:

1. I will practise dentistry only at my clinic, the Children's Oral Care Centre, located at 201-2051 McCallum Road in Abbotsford (the "Centre").
2. I will only be on the premises of the Centre if a practice monitor who has been approved by BCCOHP ("Approved Practice Monitor") is present with me.
3. An Approved Practice Monitor must
 - (a) be a health professional currently registered and in good standing with a regulatory college in BC,
 - (b) be or have been in a position of authority, to be assessed by such factors as,
 - (i) the length and level of experience as a health professional, and
 - (ii) employment, community and professional positions held,
 - (c) have no previous or current affiliation to me, the Centre or any other clinics where I have practiced, and
 - (d) sign a Practice Monitor Agreement with BCCOHP.
4. Unless an Approved Practice Monitor is present, I will not engage in any in-person communications with
 - (a) the staff of the Centre, including all full and part-time employees and any contract workers (the "Staff"),

- (b) patients of the Centre ("Patients"), or
 - (c) parents or guardians of Patients or any others persons attending at the Centre.
5. I will communicate in writing with Patients, or the parents or guardians of Patients, only
- (a) about matters relating to Patient care, and
 - (b) using surface mail or email.
6. I will communicate by telephone with Patients, or the parents or guardians of Patients, only when an Approved Practice Monitor is present or where such communications are initiated by Patients or their parents or guardians and in any event only about matters relating to Patient care.
7. I will communicate in writing or by telephone with members of the Staff, only
- (a) about practice-related matters, and
 - (b) when such communications are either
 - (i) initiated by a member of the Staff, or
 - (ii) between me and the Centre office manager.
8. I will ensure that all members of the Staff are
- (a) provided with a full opportunity to read a signed copy of these Undertakings, as well as a copy of the Practice Monitor Agreement, and
 - (b) advised of the identity of each Approved Practice Monitor.
9. I will ensure that, all Patients or, as appropriate, their parents or guardians, are advised at the time of booking a new appointment or no later than 48 hours prior to appointments already scheduled, that
- (a) I have agreed to have a regulated health professional monitor my practice and my interactions with patients and staff because there are ongoing investigations by the BCCOHP respecting my interactions with adult staff members, and that such professional will be present during their or their child's treatment. If they are not comfortable with that, I will refer them to another practitioner to ensure continuity of care.
 - (b) When they attend for their appointment at the Centre, patients and their parents or guardians will be reminded that Dr. Grewal has agreed to have a regulated health professional monitor him in his practice, and that such professional will be present during their or their child's treatment. Each health

professional has signed an agreement to comply with the Centre's privacy policy and committing to safeguard patient privacy. If the patient or their parent or guardian are not comfortable with the presence of the such professional, I will refer them to another dentist to ensure continuity of care.

- (c) The patient or their parent or guardian will then be asked to consent to the presence of the health professional during their appointment. I undertake that I will refer any patient that does not consent to treatment under these circumstances to another dentist to ensure continuity of care.
10. I will maintain professionalism, professional boundaries and appropriate conduct with all
 - (a) members of the Staff,
 - (b) Patients; and
 - (c) other persons attending at the Centre.
 11. I will immediately leave the Centre premises and voluntarily withdraw from the practice of dentistry pending further consideration by the Inquiry Committee, if an Approved Practice Monitor reports any actual or suspected inappropriate conduct to the BCCOHP.
