The Chair opened the floor for comments or questions from the Board on the committee reports. Dr. Chris Hacker, Registrar and CEO noted not all committees were represented by the reports, only those that were active in their work to report to the Board. The Patient-Centred Care Committee and the Standards and Guidance Committee were preparing reports, which would be presented to the Board at a later date.

Ms. Steph Nicholls, Senior Manager, Policy and Projects, reviewed the Quarter 3 Board Performance Dashboard which included both internal and external inputs around risk, engagement, monitoring, complaints, people, and operations. Data from the Voice of Patient survey was used to populate the dashboard and financial data would be included upon release of the budget. Results of an Oral Health Professionals survey would additionally be incorporated.

During discussion, comments were offered regarding:

- Suggestion to further break down the data by Indigenous and non-Indigenous and by geographic area
- The importance in separating Indigenous data by First Nations, Métis, and Inuit recognizing that this may require individuals to self-identify
- A better understanding is needed on rural health care, access to care, related costs, and how it compares with urban health care
- An Oral Health Professional panel comprised of 40 individuals contributed to the research
- Ensuring data from under-housed and vulnerable populations is obtained
- Using alternate methods to engage with people during the complaint process
- Surveying registrants on the BCCOHP operations, specifically their experience with the registration process and health monitoring, to identify any points of discrimination
- Google tags placed on the BCCOHP website will inform a journey mapping exercise of how individuals use the website.
