

# MEMORANDUM OF ACKNOWLEDGEMENT AND UNDERTAKING (MAU) BETWEEN THE

## COLLEGE OF DENTAL SURGEONS OF BC (THE COLLEGE)

#### AND

### DR. IVY KWOK SUEN YU

#### 1. I, DR. IVY KWOK SUEN YU.

- (a) understand that with respect to the complaint made by behalf of her son College Complaint File #104540, the College considered that I would benefit from an educational program to enhance my diagnosis and treatment planning and informed consent as it relates to orthodontic treatment;
- (b) undertake to complete the "for credit" version of the College's online "More Tough Topics" course (available on the College's website <a href="www.cdsbc.org">www.cdsbc.org</a> under the "Practice Resources" heading), within 3 months of signing this MAU;
- (c) confirm that, since its execution, I have complied with the Memorandum of Agreement and Understanding with the College, dated 8 November 2018, and will continue to do so in the future. Specifically, I will not provide any orthodontic services for any patient until:
  - I have successfully completed a degree or equivalent qualification from a specialty program in orthodontics and dentofacial orthopedics at postsecondary educational institution that has been accredited in accordance with the College Bylaws, and
  - ii) I have obtained certification as a certified specialist in orthodontics and dentofacial orthopedics in accordance with the College Bylaws Part 6 section 6.05 (3) or such other Bylaws as are then in place;
- (d) understand and agree that this MAU is made with respect to a "serious matter" as that term is defined in s. 26 of the Act and that public notification will be made pursuant to s. 39.3 of the Act by publication of this MAU in its entirety except that the name of the complainant will be redacted;



- (e) agree to respond to any requests from the College in a timely manner;
- agree that I will promptly inform the College in writing when I comply with any requirement of this MAU;
- (g) understand that a monitoring file will be opened to keep track of my progress in completing the "for credit" version of the College's online "More Tough Topics" course, as stipulated in paragraph 1.(b) above. The monitoring file will be closed upon my completion of that course;
- (h) agree that if a deadline or requirement has not been met, I will immediately inform the College that it has not been met;
- (i) understand that this MAU may be taken into account in the event of a future complaint;
- (j) confirm that I have read and understand this MAU, and have had the opportunity to obtain legal advice on its contents;
- 2. THE COLLEGE OF DENTAL SURGEONS OF B.C., through its Registrar, has advised Dr. lvy Kwok Suen Yu:
  - it may view any breach of this MAU once signed as unprofessional conduct;
     and
  - that following the successful completion of the terms of the MAU, specifically 1.(b) above, the monitoring file will be closed.
